ORDER:

WHO has declared Covid-19 outbreak as Pandemic. Government of Andhra Pradesh has declared several measures to strengthen surveillance for Containing, Control and Prevention of Covid-19 including effective management of the Lock Down.

- 2. In this connection, the District Collectors have reported that, they require certain uniformed services like Officers and staff of Prohibition and Excise, Forest, Transport, APSRTC etc., for helping Police to effectively enforce the Lock down declared by the Government. Similarly, they are also requiring the services of Officers and Personnel from various Departments for management of essential services and also to take measures for effective Containment Control and Prevention of spread of Corona Virus (Covid-19).
- 3. Government after careful examination of the matter, hereby direct all the Government Departments including Corporations/Autonomous Institutions to make available their Officers and staff as per the requisitions received from the District Collectors in order to enforce the Lock Down effectively and to take up various measures to strengthen the surveillance for Containment, Control and Prevention of Covid-19.
- **4.** However, as the liquor shops are closed by the Government throughout the State there will be chances of flow of spurious liquor which may lead to the people taking such liquor with disastrous consequences. Similarly, Forest Department also may require skeleton staff to ensure protection of the forest such that, scrupulous elements will not take away precious resources.

- **5.** All the District Collectors shall assess requirement and limit requisition to $1/3^{rd}$ of the available strength of the two Departments i.e., Prohibition & Excise and Forest at the District level.
- **6.** All the Departments including the Corporations/ Autonomous Institutions shall follow the orders scrupulously.
