**ORDER:**

The Government of Andhra Pradesh have provision of approved **JaganannaVidyaKanuka**" to implement a programme for student kits to facilitate the children to pursue their studies. The program is aimed at 100% participation of students in the schools leading to achievement of better learning out comes.

In this regard the Regional Joint Directors, District Educational Officers and Additional Project Directors Samagra Shiksha in the State are informed that Hon'ble Chief Minister of Andhra Pradesh is going to launch the "**JaganannaVidyaKanuka**" prestigious flagship scheme programme on 5<sup>th</sup> October, 2020 for distribution of the student school kits consisting of 1 School Bag, 1-Belt, Pair of shoes & two Pairs of Socks , 3 pair of Uniforms along with Notebooks, Work Books and Text Books for the use of school children studying in Government management schools, aided schools and Madarasas of Andhra Pradesh for the academic year-2020-21 for the classes I to X.

Further, they are informed that the kits are being acknowledged by the mothers concerned through a mobile application with biometric authentication. The user manual is herewith attached for ready reference. Sri.CHVS.Ramesh Kumar, Lecturer, DSCERT has identified as Nodal Person for implementation of "**JaganannaVidyaKanuka**" till the distribution of Kits.

Therefore, all the DEOs and APCs of SS are requested to go through the guidelines thoroughly and to ensure all the JAGANANNA VIDYA

KAANUKA kits are distributed properly with due biometric authentication of the mother/guardian concerned with the precautions and protocol of COVID-19 pandemic. And they are instructed to **depute the e Hazar Nodal Person** for the said task till completion of distribution.

Therefore all the Joint Collectors of Development, Regional Joint Directors of School Education and District Educational Officers and Additional Project Coordinators of SS in the State are requested to follow the above instructions for distribution of the above material to all Mothers/Guardians of all students studying from Class I to X in all Government/Aided/Madrassas management schools for the academic year 2020-21.

Further State Project Director, Samagra Sikhsha, is requested to constitute a special Monitoring cell to monitor the distribution of the kits and to redress the grievances received from the Districts, if any under the said program and to send day wise status report to the undersigned.

2. Should Invite Hon'ble Ministers of respective Districts for inaugural of "**JaganannaVidyaKanuka**" in any of the schools identified by District Educational officers.
3. Should invite respective MLC/MLAs for inaugural of "**Jagananna VidyaKanuka**" and issue instructions to MEO's to accompany.
4. District Collector, Joint Collectors & Senior officers of the District may be invited to said inaugural to launch "**JaganannaVidyaKanuka**" in any of the schools identified by the District Educational Officer.
5. Should invite Parents Committee Members for launch of "**Jagananna VidyaKanuka**" prestigious flagship scheme programme on 05.10.2020.
6. Regional Joint Director School Education are instructed to follow up with the Respective District Educational Officer & Additional Project Coordinator and participate in any one of the school in the zone.
7. DEOs should ensure that the program should launch at 10.00 am onwards in all schools in the state.
8. Should Ensure the participation of 50 Mothers & 50 Students each day.
9. Ensure acknowledgement from mothers concerned through a mobile application with biometric authentication.
10. To depute E Hazar Nodal person on the respective district for the smooth distribution of "**JaganannaVidyaKanuka**"
11. DEOs/APCs are requested to download the application from Google Play store under as mentioned in user manual.
12. Ensure Safety norms to provide proper sanitation to the invitees including students and Mothers by duly providing sanitizer by duly meeting the expenditure from school annual grants.
13. Please ensure all protocols of COVID 19 as issued by Government of India and Government of Andhra Pradesh are followed.
14. Please ensure that all the participants strictly adhere to mask wearing and social distancing.
