Visakhapatnam	Smt V.Suneetha, SA(BS) was transferred on rationalisation 2017 and again the post was rationalised and hence she was compulsory transfers. She requested to award additional points of 2017 as was done during the transfers 2017	Take action as per Guideline- 8 and Note-3 of Guideline-10 of G.O.Ms.No.54 dated 12.10.2020.
