2. Judgment of the Hon'ble High Court of Judicature at Hyderabad for the State of Telangana and State of Andhra Pradesh in W.P.No.20285/2014 dated 23-12-2014.

The attention of the Principals of A.P. Model Schools in the state is invited to the reference 2nd read above wherein the Hon'ble High Court of Judicature for the State of Telangana and State of Andhra Pradesh at Hyderabad have issued the following Judgment dated 23-12-2014 in the said W.P. No.20285/2014 and batch:

"...that the respondents can fill up the vacancies in all the schools but they are directed to allot the places to the candidates in both the merit lists in accordance with their merit and also basing on the choice exercised by them. ... but the respondents are directed to follow the merit lists as well as the web options exercised by the candidates in both the merit lists and issue fresh posting orders strictly in accordance with merit. ..."

In view of the above, all the working TG teachers in A.P. Model Schools are here by directed to exercise their web options from 18.02.2015 to 27.02.2015 in APMS website. If any teacher fails to exercise web option on any reason what so ever it may be, it will be at his/her risk only and the place will be allotted from the left over vacancies and is binding on the individual to join at the allotted place. It is also informed that the selection of places will be strictly on the rank secured in the selection list only. The working teachers on receiving the fresh posting order has to get relieved at the working place on 03.04.2015 and has to join at the place of posting immediately and the newly selected candidates also join at the places allotted to them on 03.04.2015.

Hence, all the Principals of the A.P. Model Schools are directed to bring this information to the notice of all working TG teachers in the schools immediately under acknowledgement and preserve the same in their office, so as to enable them to exercise web option as per judgment in W.P.No.20285/2014 and batch dated 23.12.2014.
