The attention of all the Commissioners of Municipalities/Municipal Corporations in the State are invited to the reference cited (copy enclosed) wherein the Principal Secretary to Municipal Administration Department have issued instructions that all the Municipal Schools where foundation classes are conducted, the Municipal Commissioners concerned shall implement Mid Day Meal Scheme, and to provide Drinking Water, Toilets facilities in adequate and the expenditure for this purpose may be met from the General funds or from the budget of Mid Day Meal Scheme, and also informed that the study material for foundation course shall be prepared and printed by Guntur Municipal Corporation and distributed to all the Municipal Schools in the State where foundation courses are conducted. Scanners may also be provided to the Municipal Schools procuring through APTS.

Therefore, the Commissioner, Municipal Corporation, Guntur is requested to prepare and print the study material for foundation course and distributed to all the Municipal Schools in the State and also provide scanners (procuring through APTS ) to the Municipal Schools where foundation courses are conducted as per the above instructions of Government.

Further, all the Commissioners of Municipalities/Municipal Corporations in the State are directed to take immediate action on implementation of Mid Day Meal Scheme, Provide Drinking Water, Toilets facilities in adequate in Municipal Schools in the State where foundation courses are conducted, and the expenditure for this purpose may be met from the General funds or from the budget of Mid Day Meal Scheme and inform the action taken report to this office immediately.
