The under mentioned officers are informed that, Government have issued G.O.Ms.No.55 Edn. (Ser.III) Department, Dt.23.04.2011 and G.O.Ms.No.61 Edn. (SE-SER-III) Department, Dt.16.05.2011 issued norms for Rationalization of Schools, Posts, and Staff under various management viz., Government, Zilla Parishad, Mandal Praja Parishad, Municipal Schools.

It is found that, there are some school with higher student strength vis-à-vis the sanctioned teaching post and on the other hand some schools with uneconomic strength of students have more teachers.

Hence, the department earlier constituted a working group to examine teacher – pupil ratio (TPR) at the State and District level, at the School level and felt, it needs to be improved.

Government in G.O.Ms.No.39 Edn. (Ser.II) Department, Dt.07.08.2015 to G.O.Ms.No.51 Edn. (Ser.II) Department, Dt.07.08.2015 read with G.O.Ms.No.86 Edn. (Ser.II) Department, Dt.03.11.2015 to G.O.Ms.No.98 Edn. (Ser.II) Department, Dt.03.11.2015 issued orders indicating norms for Establishment of Model Primary Schools in the State.

The report of the Working Group regarding revision of rules issued in G.O.Ms.No.55 Edn. (Ser.III) Department, Dt.23.04.2011 and G.O.Ms.No.61 Edn. (SE-SER-III) Department, Dt.16.05.2011 was submitted to Government vide this office Lr.Rc.No.25/Estt-III/2015, Dt.30.06.2015 stipulating teacher requirement in Primary Schools, Upper Primary (I to V class), Upper Primary (I to VIII classes), Success High School (VI to X) English Medium, High Schools (Success & Non Success High Schools) (VI to X Classes), Parallel English Medium Sections and Parallel Medium High School (Minor Medium). A copy of same was also furnished to the District Educational Officers in the State and also the Recognized Teacher Union Associations.

After submission of the proposals to the Government certain Teachers Associations, Teachers have represented that, the revised norms require further improvement and revision, and requested for certain changes in the proposed norms to have a workable and evenly distribution of work.

In view of the above, the Commissioner of School Education, Andhra Pradesh, Hyderabad hereby constitute a Committee with following officers to study the 30.06.2015 proposals to Government and suggest revised norms taking realist approach, duly keeping RTE norms, teacher pupil ratio, subject weightage, allocation of periods, work load etc.,
