In pursuance of the orders issued in the G.O 1<sup>st</sup> read above, Government have framed certain Rules to the Constitution of the Andhra Pradesh Civil Services Joint Staff Council (State Level) and accordingly, every year Government have reconstitutes the Andhra Pradesh Civil Services Joint Staff Council (State Level).

**2.** Government in the reference 2<sup>nd</sup> read above, have accorded sanction for "Other Duty" facility for the Permanent Member Associations in the A.P.Civil Services Joint Staff Council (State Level) by pending reconstitution of A.P.Civil Services Joint Staff Council (State Level) for the year 2015, for the period from 01.01.2015 to 31.12.2015 based on their eligibility. In respect of A.P.United Teachers Federation the O.D. facility have been sanctioned up to 13.12.2015 only, for the calendar year 2015 ie., as per their term.

**3.** In the reference 3<sup>rd</sup> read above, the President/General Secretary, A.P. United Teachers Federation, have stated that, they have conducted their annual State Body elections in their 41<sup>st</sup> State Council Meetings held at Ongole on 14.12.2015, and they have been unanimously elected as State President and State General Secretary respectively during the above Council Meetings and requested the Government for extending the O.D. facility for the remaining period from 14.12.2015 to 31.12.2015 for the Calendar year 2015.

**4.** Government after careful examination of the matter hereby accord post facto sanction of "Other Duty" facility for the period from 14.12.2015 to 31.12.2015, to the Office Bearers i.e, the State President and the State General Secretary of A.P. United Teacher's Federation, for the calendar year 2015, on full time basis, by keeping the post held by them vacant and allow them to draw pay and allowances from their respective parent Department.
