In the notification published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R. 30 (E) dated the 14th January, 2020 which have rescinded the notification number G.S.R 928 (E), dated the 26th October, 1989, due to typographical error, it was mentioned that the Government of the State of Andhra Pradesh after obtaining the concurrence of the High Court of Andhra Pradesh had made a request for abolition of the Andhra Pradesh Administrative Tribunal.
