ORDER

The Government of Andhra Pradesh have decided to supply Student Kits consisting of (3) pairs of uniforms Cloth, Text Books, set of Notebooks, a pair of shoes and two pairs of socks, a belt & School bag to all the students studying from Classes I to X in all Government/MPP/ZPP/Municipal/Residential Schools of Education & Welfare Departments/Ashram Schools/Aided Schools/ Model Schools/KGBV/Registered Madarsas in the state under "Jagananna Vidya Kanuka".

- 2. In the reference 3rd & 4th read above, the State Project Director, Samagra Shiksha, submitted a proposal for issuing Administrative approval to take up the procurement and supply of Students KITs with the components i.e., Uniform Cloth, Text Books, a set of Note Books, a pair of Shoes and two pairs of Socks, a Belt and School Bag to all the School students studying in classes I X in all Government Management Schools during the Academic Year 2020-21 and to minimize the dropouts, which will directly impact the enrollment, students participation in the learning activity and thereby improve the learning outcomes of the children.
- 3. The Government constituted a High Level Committee to prepare, evaluate and approve the tender documents and procurement is made through e-procurement process with reverse tendering in the reference 5th cited. The Government also ordered to include the proposal of supply of Student Kits under Samagra Shiksha for the year 2020-21 and the 40% matching State Share will be released through Green Channel PD Account.
- 4. The total estimated cost of the scheme of "Jagananna Vidya Kanuka" component wise, number of beneficiaries, state share and central share is as follows.

- 5. Government after careful examination of the matter hereby accord administrative sanction for procurement and supply of student kits under "Jagananna Vidya Kanuka" and to propose the same for under Annual Working Plan and Budget (AWP&B) of Samagra Shiksha for 2020-21 with 60% grants from Government of India and 40% grants from the Government of Andhra Pradesh during the financial year 2020-21.
- 6. Since the material has to reach the students by the time of reopening day of the schools for the academic year 2020-21, i.e. 12th June, 2020, action has to be initiated for procurement of the material well in advance, permission is hereby accorded to State Project Director, Samagra Shiksha, AP, Vijayawada to prepare, evaluate and approve the tender documents and procurement is made through e-procurement process with reverse tendering through the High Level Committee Constituted vide reference 5th read above.
- 7. However, in the above (6) items, Textbooks shall be printed through AP Government Textbook Press as per the usual practice and they shall not be included in the tenders under this program.
- 8. The Commissioner of School Education/State Project Director, Samagra Shiksha shall take necessary action accordingly.
