In the reference 2<sup>nd</sup> read above, the Commissioner of School Education, A.P. has stated that Smt.S.Nagaveni, Secondary Grade Teacher, MPPS, Patharlapalli, SC Colony, Ranasthalm Mandal, Srikakulam District, expired while in service on 11.03.2015 due to brain tumour. Sri Ravada Polayya, husband of the diseased employee, has submitted application within one year after the death of his wife. But, he has crossed 45 years of age on the date of submission of application for compassionate appointment. The Commissioner of School Education, A.P. has requested the Government to issue necessary relaxation orders to Sri Ravada Polayya as he crossed 45 years of age on the date of submission of application for compassionate appointment, as a special case.

2. After careful examination of the matter, Government hereby accord permission to the Commissioner of School Education, A.P. to appoint Sri Ravada Polayya, Husband of Late Smt.S.Nagaveni, Secondary Grade Teacher, MPPS, Patharlapalli, SC Colony, Ranasthalm Mandal, Srikakulam District, in a suitable post on compassionate grounds, in relaxation of rules with regard to upper age limit of 45 years, subject to fulfillment of all other eligibility criteria for such compassionate appointment.

3. The Commissioner of School Education, A.P. shall take necessary further action in the matter accordingly.
