ORDER:

In the reference 1st read above, Government have communicated the recommendations of the Sectoral Sub Committee on Training institutions and Centres under Schedule-X of A.P Reorganisation Act 2014, with regard to A.P. Residential Educational Institutions Society which states that “this organization i.e., APREIS has been established as a Society and in view of the duties performed by the Society, it is recommended to divide before Appointed Date”.

2. In the reference 3rd read above, the Secretary, A.P. Residential Educational Institutions Society, Hyderabad has informed that a Special Resolution of the Board of Governors of the A.P. Residential Educational Institutions Society has been prepared and obtained orders from the members of Board of Governors, on the following points:

- i. In the light of the reorganizations of the State under the A.P. Reorganization Act, 2014 and under the powers vested under Section 21(2) of the A.P. Societies Registrations Act, 2001, the A.P. Residential Educational Institutions Society may be divided into two Societies and
- ii. Assets and Liabilities of Society shall be divided among the two new Societies as per the area of location and operation of Institutions. The area of operation of Residuary Andhra Pradesh State is (13) districts of Semandhra Region and for Telangana State is (10) district in the existing Telangana Region.

3. The Secretary, APREIS has therefore requested the Government to permit the Secretary, A.P. Residential Educational Institutions Society , to Register two new Societies viz., Andhra Pradesh Residential Educational Institutions Society for Residuary Andhra Pradesh State and Telangana Residential Educational Institutions Society for Telangana State under Societies Registration Act 2001 and to authorize

the Secretary, A. P. Residential Educational Institutions Society to prepare to prepare Memorandum of Association, Rules and Bye-Laws for the two Societies Separately with the approval of the Prl. Secretary to Govt. School Education / Vice-Chairman, APREI Society.

4. Government after careful examination of the proposal of the Secretary, APREIS, Hyderabad and in pursuance of the recommendations in the reference 1st read above, permission is hereby accorded to the Secretary, A.P. Residential Educational Institutions Society, Hyderabad, for registration of the new Societies viz., Andhra Pradesh Residential Educational Institutions Society for Residuary Andhra Pradesh State and Telangana Residential Educational Institutions Society for Telangana State under Societies Registration Act 2001. Further the Secretary, APREI Society is authorized to prepare Memorandum of Association, Rules and Bye-Laws for the two Societies separately with the approval of the Prl. Secretary to Govt. School Education / Vice-Chairman, APREI Society.

5. The Secretary, A.P. Residential Educational Institutions Society, Hyderabad is requested to take further necessary action accordingly.
