ORDER:

1. Smt. Velaga Venkateswaramma, School Assistant, ZPHS.Girls, Vinukonda, Guntur District and 5 others have approached the Hon'ble High court vide W.P.No.21482 of 2020 seeking direction to show all the places as vacancies for general transfer of teachers in all the schools including 2019 promoted places in effecting transfers through the Transfer Schedule issued vide proceedings in Rc.No.13029/11/2020EST-3,CSE dated 02.11.2020 issued by the respondent No.2 in pursuance of G.O.Ms.No's.53 and 54 School Education Ser.II Department dated 12 10 2020.

2. That vide ref no.1 Hon'ble High court was pleased to pass interim orders as follows:

"..the respondent No.s 2 to 8 are directed to show the places where vacancies arise for general transfer of teachers in relevant schools including such of those places where promoted individuals were posted during the year, 2019 by 03.12.2020, such vacancy position shall be displayed at the time of the proposed counselling."

3. That vide ref no.2 contempt case vide 1369 of 2020 in WP 21482 of 2020 is filed for not implementing the orders dated 14.12.2020 and at the time of admission of contempt case, the Hon'ble High court passed the orders as follows:

"Heard Smt.Kavitha Gottipati, learned counsel for petitioner.

Notice before admission.

List on 18.12.2020.

In the meantime, the respondents 1 and 2 are directed to implement the order in I.A.No.1 of 2020 in W.P.No.21482 of 2020 dt.24.11.2020 displaying the vacancy position as directed. Since it is represented by the learned counsel for the petitioner that web counselling is going to come an end by 15.12.2020, the petitioner is permitted to serve a list showing such vacancy position on the respondents 1 and 2 by 6.00PM this day, which shall invariably be displayed for the purpose of counselling on 15.12.2020.

Office is directed to upload this order immediately. A copy of this order be issued to the learned counsel for the petitioner now itself.

Learned counsel for the petitioner is also permitted to communicate gist of this order to the petitioners as well as the respondents 1 and 2 by WhatsApp message."

4. That as the counter and vacate stay petition is filed and same is pending for consideration before the Hon'ble High court, in obedience of the orders dated 14.12.2020 in WP 21482 of 2020 and also in pursuance of the contempt case, the O/o. District Educational Officers of Guntur, Krishna, Prakasam, Nellore, Kadapa, Chittoor are hereby informed that the orders issued to the District Educational office's vide ref no.3 so far as directing to publish the vacancy list as on 7.12.2020 without including 2019 promoted places as vacancies are herewith cancelled and directed to publish the vacancy list by including 2019 promoted places as on 7.12.2020 subject to the outcome of the WP.No.21482 of 2020 and report compliance by 9.1.2020.
