In the circumstances stated in the reference 4th & 5th read above, Government after careful consideration of the matter as per the uniform rates of remuneration fixed by the Election Commission of India in the reference 1st read above, hereby issue orders fixing the following rates of remuneration payable to the staff deployed on training classes/polling /counting duties during Ordinary Elections to Urban Local Bodies, 2020/21 in the State :

1	Zonal Officer/Route Officer/Sectoral Officer	Rs.1500/- one time remuneration at lumpsum
2	Presiding Officer / Counting Supervisor	Rs. 350/- per day
3	Polling Officers / Counting Assistant	Rs. 250/- per day
4	Office Sub-Ordinates (Class-IV)	Rs. 150/- per day
5	Packed lunch and/or light refreshment to the personnel deployed at polling stations / counting centre	Rs. 150/- per head per day

2. The Secretary, A.P. State Election Commission, Vijayawada shall take necessary action accordingly.
