With reference to Govt., memo 6th cited, I wish to submit that the District Educational Officer, Guntur has been instructed to examine the proposal with reference to the rules as per para 2 (iii) of the instructions issued in U.O.Note.No.450/Ser.C/91-1, General Administration (Ser.C) Department, dt.24.10.1991 and submit a detailed report with specific remarks.

Further, I am to inform that the District Educational Officer, Guntur has submitted that regarding Non-implementation of merit-cum roaster while promoting SGTs as Schools Assistants during 2002 at that time as follows:-

- 1. In October, 2002, the promotions to the teachers to the post of certain School Assistant(s) cadres were conducted with the seniority list prepared on merit basis.
- 2. 2. Some of the teachers aggrieved by the action of the District

- Educational Officer, Guntur and filed OA No.4759/2005.
- 3. The Hon'ble APAT in the final judgement dt.27-4-2010 in the above said OA has upheld the position of the Department in connection with the conduct of promotion counselling in 2002 on merit basis/ DSC ranking.
- 4. The District Educational Officer, Nalgonda challenged in High Court for upholding his stand for implementing merit-cum-roster method, whereas this office has already implemented the merit-cum-roster in 2009 itself, and there is no court cases filed against the merit cum-roster method in this District.
- 5. The District Educational Officer has also submitted that, before 2002, the Zilla Parishad (ZP) authorities had conducted promotion counselling. Further in October 2002 merit basis is followed and after 2002 up to 2009 merit cum Roster procedure was followed in sanctioning Promotions.
- 6. Further the District Educational Officer has stated that during promotion counselling for the post of School Assistants held in October 2002, promotions were given on the basis of merit ranks obtained in DSC 1994and DSC 1996 for Maths, Physical Sciences and English.
- 7. The individuals are requesting that they lost their promotion due to the procedure followed by the District Educational Officer at the time i.e., in2002. If they follow merit cum roaster for preparation of seniority list they will get promotions in 2002 itself and they are now requested to consider for notional seniority.
- 8. Hence, the perception of the applicants is that the merit-Cum-roster system should have implemented in 2002 itself. Hence, they are claiming for the notional seniority. Since, they were promoted in 2009.

Further, I wish to inform that instructions have been issued to the District Educational Officer, Guntur for furnishing of certain documents for taking further action in the matter. Accordingly, the DEO, Guntur has furnished the following copies:

i.Copy of DSC-1994 Seniority List.

ii.Copy of DSC-96 Seniority list.

iii. Copies related for promotion 2002.

In view of the above, I request the Government to issue necessary orders regarding notional seniority requested by the applicants.
