ORDER

The Commissioner & Director of Municipal Administration, AP, Guntur in the reference read above, has submitted proposal stating that Government have issued orders constituting Mangalagiri Tadepalli Municipal Corporation by merging the areas covered under Mangalagiri Municipality and Tadepalli Municipality. Further, he has stated that, certain public representatives have requested to merge all the schools under the Panchayat Raj Dept., i.e., Zilla Parishad and Mandal Praja Parishad Managements, existing in the limits of Mangalagiri Tadepalli Municipal Corporation into the Municipal Management for effective monitoring and implementation of different Government Schemes/ Programmes on par with Municipal Schools to enable to cater the needs of pupils. Further, they have also informed that it is convenient for administration and monitoring of schools in single management as there are different managements with various rules and regulations. Further he submitted that as per the provisions of Municipal Act and Rules, after merging of certain areas into the limits of Municipal Corporation/ Municipality/ Nagar Panchayat, as the case may be all assets and liabilities located in that areas which pertains to Gram Panchayat come under the administrative control of Municipal Corporation/ Municipality/ Nagar Panchayat. The ULBs provides all the civic amenities viz. roads, drains, sanitation, street lighting etc., in the merged areas including in and around the ZP & MPP Schools. All these schools are located in the merged areas/ villages/ colonies of Municipal Corporation/ Municipality/ Nagara Panchayat when it is merged and still continued to be under different Managements. At present, these schools are under control of the School Education Department and these schools are yet to be transferred from Pachayt Raj Department to Municipal Administration Department. Further he stated that as per G.O.Ms.No.18, MA&UD Dept., dated 07.01.2019, after constitution of any ULB, the Special Officer concerned shall take charge of all movable and immovable properties, all the office records of Grampanchayts etc.

2. Therefore, the C&DMA, AP, Guntur has requested the Government to issue necessary orders in the matter.

3. Government after careful examination of the matter in consultation with PR&RD/ School Education/ Finance Department hereby order for merger of MPP/ZPP Schools located/ existing in the limits of Mangalagiri Tadepalli Municipal Corporation into the Municipal Management under MA&UD Department..

4. The School Education Department is requested to take immediate necessary action for rationalization/ re-apportionment of teaching staff working in the MPP/ZPP Schools to be merged into Mangalagiri Taddepalli Municipality based on the recommendations of the Committee during the year 2013 constituted on the merger of ZP/ MP Schools duly following the procedure The PR&RD department is requested to transfer the movable and immovable assets to the administrative control of MA&UD department as per provisions of Municipal Act and as per G.O. 18, MA&UD department Dt.07.01.2019.

5. The Commissioner & Director of Municipal Administration, AP, Guntur shall take further necessary action in the matter accordingly.
