I invite kind attention of the Government to the references cited and submit that, in the reference 3rd cited, the Government have requested the C&DMA to indicate the policy and financial implications of the current proposal to Government for taking necessary further action in the matter regarding for sanction Notional increments to the Special Teachers/ Special LPs/ PETs who are appointed on fixed pay of Rs.398/- p.m. during the period from 1983 to 1996 with prospective effect to Municipal Teachers, for the purpose of pension only, on par with School Education Dept.

2. In this regard, I submit that vide G.O.Rt.No.429, Education (EE.1) Dept., dated 13-10-1983, the Government in School Education have introduced a scheme of appointment of Special Teachers, Special Language Pandits and Special Physical Education Teachers on payment of fixed pay of Rs.398/- per month without any other allowances. Subsequently, the

Government in School Education have issued orders for considering the temporary service of the above teachers who were appointed between the years 1983-1996 with a consolidated pay of Rs.398/- and absorbed in regular posts for the purpose of appointment to automatic Advancement Scheme notionally and also for pensionary benefits vide GO.Ms.No.119, dated 21-04-1998 and GO.Ms.No.92, dated 08-08-2000 of the Education (Ser.III) Department and GO.Ms.No.71, dated 05-11-2018 of the School education (Ser.III) Department.

3. Further, I submit that, the Government in School Education have issued further orders for sanction of notional increments to the Special Teachers, Special Language Pandits and Special Physical Education Teachers who are appointed on consolidated pay of Rs.398/- per month during the period from 1983 to 1996 with prospective effect, for the purpose of pension as per request of the Commissioner of School Education, A.P. vide reference 1st cited.

4. With regard to Financial implication on implementation of above orders to the Municipal Teachers, I submit that, all the Commissioners of the ULBs have been requested to submit the reports on financial implication for implementation of GO.Ms.No.28, Education (Services.II) Dept., dated 01-03-2019 through the RDMAs. In reply, the RDMAs have submitted consolidated report for taking further action.

5. As seen from the reports received from the ULBs, the ULBs have arrived the financial implication per teacher as the difference between the Basic pay at the time of retirement and Basic pay at the time of retirement after sanction of the notional increments, as applicable (i.e., from date of joining to date of absorption in regular post). Accordingly, 341 no. of Municipal Teachers will be effected and financial implication is about of Rs.4.97 lakhs per month (i.e., 50% on Rs.9.94 lakhs) without allowances as applicable on sanction of Notional increments to the Special Teachers/ Special LPs/ PETs who are appointed on fixed pay of Rs.398/- p.m. during the period from 1983 to 1996 with prospective effect, for the purpose of pension only, on par with School Education Dept. as per G.O.Ms.No.28 School Edn., dt.01.03.2019 (List Enclosed).

6. This is submitted for information and taking further action in the matter.
