The attention of all the Regional Joint Directors of School Education and the District Educational Officers in the state are invited to the references read above and they are informed that the Government have accorded permission to the Commissioner of School Education to implement the orders of Hon'ble High Court regarding revision of pension and to refund the recovery amount vide references 1<sup>st</sup>&2<sup>nd</sup> read above, to avoid further legal complications in the matter.

As such, the list of all court orders (119 Act-I of 2005 cases) available in this office is herewith enclosed for ready reference. It is learnt that some of the cases are pending with treasury and some of the cases are pending with DEOs. The number of cases implemented information is not known to this office because compliance reports are not submitted to this office.. Hence, all the Regional Joint Directors of School Education and all the District Educational Officers in the state are requested to examine the each case and implement the Hon'ble High Court Orders and to take necessary steps for payment of recovered gratuity and revision of pension according to the rules and their eligibility immediately to avoid further legal complications in the matter. Further, they are informed that if any similar case is not in the list, they are instructed to implement the such cases also.

Hence, all the Regional Joint Directors of School Education and all the District Educational Officers in the state are directed to issue necessary instructions to the concerned DDOs to prepare bills and submit the same to the Sub Treasury Officers regarding to revision of pension and to refund the recovered amount as per their eligibility and to avoid legal complications in the matter.

The Regional Joint Directors of School Education in the state are hereby directed to contact the District Educational Officers in their Jurisdiction and review the matter every week and to implement the court orders and see that no contempt case has to be filed against the department. If any deviations in this

regard they are personally held responsible beside disciplinary action.

Finally all the District Educational Officers in the state are instructed to

take personal attention and submit compliance report for each case within 15

days from the date of receipt of this order, and also informed that if any

erroneous payment is made in the matter, the concerned DDOs will be held

responsible for such erroneous payment.
