The attention of the Commissioners of ULBs where Municipal Schools exists in the State is invited to the references cited and inform that in the reference 6th cited the Commissioner of School Education has informed that, mapping of cadre strength of Municipal Teachers to the cadre strength of School Education Department in APCFSS portal is required to draw the salaries of Municipal Teachers by the School Education Dept. The mapping of cadre strength is not completed and it will take time for mapping.

2. Further, the Commissioner of School Education has informed that the last date for submission of salary bills is 25th of every month vide

23.03.2020 and unless & until mapping the cadre strength of Municipal

Teachers to the cadre strength of School Education Department is

completed, drawing of salaries of the Municipal Teachers may not be

possible.

3. While informing the above situation, the Commissioner of School

Education, AP has requested to draw the salaries of the Municipal

Teachers by the existing DDOs i.e., Municipal Commissioners until and

unless the completion of the above said process at their end.

4. Therefore, the Commissioners of ULBs where Municipal Schools

exists are requested to take immediate necessary steps to draw the

salaries of the Municipal Teachers for the month of August, 2022 and

report compliance through the RDMAs concerned. They are also requested

to send the exact cadre strength particulars of the Municipal Teachers in

the prescribed proformas already communicated vide this Office Circular

Roc No.21024/193/2022/E, dated 24.08.2022, immediately, without fail.

5. All the RDMAs in the State are requested to guide the Commissioners

of ULBs in their region and ensure the above instructions are complied

with by all the Commissioners in the respective regions without any

deviation.

I wish to submit that, in the reference 6th cited, the Commissioner and Director, Municipal Administration, Andhra Pradesh has addressed a letter to the Director of Treasuries and Accounts, Ibrahimpatnam, Vijayawada and requested to take necessary steps/to issue necessary instructions to the concerned for mapping the cadre strength of Municipal Teachers to the cadre strength of School Education Department so as to enable the School Education Department to draw the salaries of Municipal Teachers from the month of August, 2022 in view of the orders of the Government. But, mapping the cadre strength of Municipal Teachers to the cadre strength of School Education Department is not processed till today.

Further, in the reference 7th cited, the Commissioner and Director,

Municipal Administration, Andhra Pradesh has been requested furnsih the actual cadre strength of municipal teachers as there is a variation from the cadre strength obtained from Municipal Administration through the concerned DEOs and the cadre strength mentioned the G.O.

Further, I submit that the last date for submission of salary bills is 25th of every month vide G.O.RT.No.737, Finance (Cash Management) Department, dated: 23.03.2020.

Further, I submit that, it is required to be mapped the cadre strength of Municipal Teachers to the cadre strength of School Education Department so as to enable the School Education Department to draw the salaries of Municipal Teachers. So, it will take time for processing of drawing of salaries in respect of Municipal teachers due to the non mapping the cadre strength of Municipal Teachers to the cadre strength of School Education Department. Hence, on such time it is not feasible to draw the salaries in scheduled date for the month of August, 2022.

In view of the circumstances, I request you to draw the salaries of Municipal teachers until and unless the completion of the above said process at their end and to avoid further complications in the matter.
