ORDER:-

In pursuance of the orders issued in the G.O.Ist read above, Government have issued orders to restore deputation facility to the office bearers of the Member Service Associations duly withdrawing managerial subsidy of Rs. 10,000/- per annum on full time basis by keeping the post held by the officer bearer nominated on the A.P.C.S.J.S.C. vacant and allowing him/ them to draw the pay and allowance from his/ their parent department.

2. Vide reference 2nd read above, Government have framed certain Rules to the Constitution of the Andhra Pradesh Civil Services Joint Staff Council (State Level) and accordingly, every year Government have reconstituting Andhra Pradesh Civil Services Joint Staff Council (State Level).
