O R D E R:

Vide G.O.Ms.No. 391, G.A. (SW) Dept. dt. 04.06.1990 read with G.O.Rt.No. 2138, G.A. (SW) Dept., dt. 04.06.1990, Government have issued orders to restore deputation facility to the office bearers of the Member Service Associations duly withdrawing managerial subsidy of Rs. 10, 000/- per annum on full time basis by keeping the post held by the officer bearer nominated on the A.P.C.S.J.S.C. vacant and allowing him/ them to draw the pay and allowance from his/ their parent department.

2. In pursuance of the orders issued in the G.O.1<sup>st</sup> read above, Government have framed certain Rules to the Constitution of the Andhra Pradesh Civil Services Joint Staff Council (State Level) and accordingly, every year Government have reconstituting Andhra Pradesh Civil Services Joint Staff Council (State Level).

3. In the G.O. 2<sup>nd</sup> read above, Government have accorded sanction for “Other Duty” facility to the State President / State General Secretary, A.P.United Teachers’ Federation (Regd.No.109/74) on full time basis, by keeping the post held by him vacant and allow him to draw pay and allowances from his respective parent department for the period from 29.03.2021 to 28.03.2022.

In the reference 3<sup>rd</sup> read above, the President / General Secretary, the A.P.United Teachers’ Federation (Regd.No.109/74), have stated that the Andhra Pradesh United Teachers’ Federation (Regd.No.109/74) conducted elections on 14.03.2022 at Anantapuramu under the supervision of Sri T.S.L.N. Malleswara Rao, Election Officer and as per Election Declaration Sri N. Venkateswarlu as State President and Sri K.S.S. Prasad, as General Secretary. Now they have requested the Government for sanction of O.D. facility from 29.03.2022 to 28.03.2023 for the term of one year.

5. Government, after careful examination of the matter, hereby accord sanction of “Other Duty” facility to Sri N. Venkateswarlu, State President and Sri K.S.S. Prasad, General Secretary, A.P.United Teachers’ Federation (Regd.No.109/74), for the period from 29.03.2022 to 31.12.2022, for the year 2022, on full time basis, duly keeping the post held by them vacant and allow them to draw pay and allowances from their respective parent Department.

6. The School Education Department/Commissioner of School Education, A.P., Vijayawada shall take necessary action accordingly.
