Kind attention is invited to the references 1st to 3rd cited, wherein a detailed report has been submitted with a request to sanction of Urdu Teachers i.e. School Asst (Maths), Sch.Asst (Phy.Sci) and Sch.Asst (Bio.Sci) to ZPHS, Islampeta (Urdu, Telugu & English media) Pedagantyada mandal of Visakhapatnam district and further requested for upgradation of Language Pandit (Urdu) and 02 SGT posts sanctioned and existed vacant in ZPHS, Islampeta into School Asst (Maths), School Asst (Phy.Sci) and School Asst (Bio.Sci) for the benefit of muslim minority students studying in ZPHS, Islampeta in Urdu Medium. But no orders received from the authorities.

In this connection, I submit that in the reference 4th cited, Sri Madeena Vali, Chairman, Parent Monitoring Committee, ZPHS, Islampeta has submitted a representation as a Spandana grievance to the District Collector, Visakhapatnam while enclosing a copy of the proceedings 5th cited with a request to consider their earlier request made by the Parent Monitoring Committee, ZPHS, Islampeta with respect to the consideration of the representation of District Educational Officer, Prakasam in Prakasam District duly converting the posts which were allotted in Reapportion – 2022 in Telugu medium as Urdu Medium Posts and requested for submission of proposals to the Commissioner of School Education in the similar lines for conversion of posts which were allotted to ZPHS, Islampeta under Reapportion-2022 as Urdu medium posts.

In this connection, I submit that the following posts are existed in ZPHS, Islampeta before Reapportion-2022 i.e. 31.08.2022 and after reapportionment of 2022 the following additional posts allotted to ZPHS, Islampeta under Telugu medium as the enrolment for all the mediums is taken into consideration for Reapportionment is 766 as on the cutoff date i.e. 31.08.2022.
