**ABSTRACT**

Automatic Advancement Scheme - Concession to the Category III teachers for appearing P.A.T. for two times within one year who have completed 16 years to become eligible to the Automatic Advancement Scheme-Amendment-Orders - Issued.

**ORDER:**

In G.O. fourth read above Government accorded concession for the category III Teachers for appearing Professional advancement Test for two times within one year in respect of those who have completed 16 years of service as on the date of issue of G.O. 2nd read above and did not possess the requisite qualification.

2. The Commissioner has stated that according to orders issued who G.O.Ms.No. 329 Education dated 10.6.1983 the teachers who were appointed before 14.7.1983 and completed 15 year of service and above need not pass the qualification prescribed for the Higher post however they have to pass Provisional Advancement Text. This benefit has not been extended or removed by the Government subsequently through any order. Further the Director has stated that in the meeting held by the Secretary to Government Education Department with J.C.T.A. on 9.3.2001 and R.R.T.U. on 13.3.2001 it was agreed to give concession to the Category III teachers who have completed 16 years' service for appearing Professional Advancement Text, for two times within a year to become eligible to the Automatic advancement Scheme and requested the Government to issue necessary orders in the matter. Accordingly Government after careful consideration of the proposals of Commissioner & Director of School Education Hyderabad accorded concession for the category III teachers for appearing Professional Advancement Test for two times within one year in respect of those who have completed 16 years in respect of issue of G.O.Ms.No. 329 Education (HI) Department dated. 10.06.1983 and did not possess the requisite qualification vide G.O.Ms.No.84 Education (Ser. V) Department dt. 25.10.2002. The Commissioner & Director of School Education in his letter dated 3.1.2003 has stated that PRTU Hyderabad have informed that as per the orders issued in G.O.Ms.No.84 Education (Ser. V) Department dt. 25.10.2002 category III teachers appointed before 14.7.1983 are eligible for appearing PAT for two times within one year who did not possess the requisite qualification. PRTU has also stated that there are no category III teachers appointed before 14.7.1983 without passing Professional Advancement Test and there is no necessity for them to pass PAT for two times. PRTU have therefore requested that necessary amendment may be issued to G.O.Ms.No. 84 School Education (Ser. V) Department allowing those category III teachers appointed after 14.07.1983 for appearing Professional Advancement Test to become eligible to the automatic advancement scheme to those who have completed 16 year of service in that category. The Commissioner & Director of School Education Hyderabad has requested the Government to issue necessary revised orders to G.O.Ms.No.84 School Education (Ser. V) Department dt. 25.10.2002 as requested by the PRTU Hyderabad.

3. In the circumstances stated by the Commissioner & Director of School Education, Hyderabad, Government in supersession of the orders issued in G.O.Ms.No. 84 School Education (Ser. V) Department dated 25.10.2002 hereby order that category III teachers appointed after 14.07.1983 and who become eligible to the automatic advancement scheme after completed 16 years of service in that category be allowed for appearing Professional Advancement Test.
