ORDER:

In the Government order 1st read above, orders were issued evolving a scheme relating to creation of Special Grade Posts, Special Temporary Promotion posts/Special Adhoc Promotion Posts in order to relieve stagnation in services to all teachers working in Government Schools, Schools under Local Bodies, Municipalities and Private Aided Managements drawing pay in the Revised pay Scales, 1978.

- 2. Further, in pursuance of the minutes of the meeting held on 14-7-1983 and 15-7-1983 between the Government and the representatives of "Federation of Andhra Pradesh Teachers' Organization" orders were issued in G.O.2nd read above, to implement the Automatic Advancement Scheme to the teachers on the basis of regrouped scales sanctioned in G.O.Ms.No. 1000(s) Education, dt.17-12-1982, subject to certain conditions, according to which all the teachers appointed before 14-7-1983 need not possess require site qualifications for getting promotion to higher post but they have to pass the professional advancement Test after completion of 15 years' service to become eligible for appointment to the special promotion Posts.
- 3. The Director, School Education, Hyd. in his letter 3rd read above, has stated that according to orders issued in G.O.2nd read above the teachers who have appointed before 14-7-1983 and completed 15 years' service and above need not pass the qualifications prescribed for the higher post, however they have to pass professional Advancement Test. This benefit has not been extended or removed by the Government subsequently through any order. Further, he has stated that in the meeting held by the Secretary to Government Education Department with the J.C.T.A. On 9-3-2001 and P.R.T.U. On 13-3-2001, it was agreed to give concession for the category III teachers who have completed 16 years' service for appearing professional Advancement Test for two times within a year to become eligible to the Automatic Advancement Scheme and requested the Government to issue necessary orders in the matter.
- 4. After careful consideration of the proposal Government hereby accord concession for the category III Teachers for appearing professional Advancement test for two times within one year in respect of those who have completed 16 years of services as on the date of issue of G.O. 2nd read above and did not possess the requisite qualification.
