I, therefore, herewith enclose the copies of the GOs in the references 6<sup>th</sup> & 7<sup>th</sup> cited, along with details in the prescribed format. I request you to create 464 new DDO codes (i.e., 451 High schools which new Headmaster Gr.II post has been allotted (due to increase in enrolment) as per the G.O.Ms.No.117, SE (Ser.II) Dept., dated.10.06.2022, G.O.Ms.No.128, SE (Ser.II) Dept., dated.13.07.2022, and 13 DDO codes to the newly created Mandal Educational Officers-I as per G.O.Ms.No.154, dt 16.9.2022) and to delete the 373 DDO codes where the Headmaster post was withdrawn (due to decrease in enrolment), to facilitate timely salary processing for affected teachers.
