I wish to inform you that in the reference 10th cited, the Government has permitted the Commissioner of School Education, A.P. to pay the salaries to the DSC-1998 MTS Teachers from the Head of Account i.e.2202-01-103-00-05-300/301 from which the salaries of the DSC-2008 MTS Teachers are being paid.

Further, it is informed that in the reapportionment process, Minimum Time Scale Teachers were allotted as SGT in High Schools/Cluster High Schools (Classes 1 to 10) for academic purpose. In these schools, provision was made under the Head of Account 2202-01-103-00-05-300/301 to draw the salaries of DSC-1998 and DSC-2008 MTS Teachers against sanctioned SGT posts in High Schools (Classes 1 to 10). But the STOs/ATOs are rejected the bills due to this Head of Account is provided for MEO to draw the salaries and not High Schools.
