In the reference 1st read above, this office has submitted proposals to Government for upgrading the (668) posts of Language Pandits and Physical Education Teachers working in the Tribal Welfare Department as School Assistants on par with School Education Department upgraded vide G.O.Ms.No.91 School Education (Services.II) Dept., dt.17.12.2018 and G.O.Ms.No.77 School Education (SER.II) Dept., dt.30.12.2019.

In the reference 2nd read above, the Government have accorded permission for up-gradation of (251) posts i.e., Language Pandits (Telugu-98), (Hindi-93) and Physical Education Teachers (60) to the cadre of School Assistants in the TW Ashram High Schools which are not having School Assistant posts in the subjects of Telugu, Hindi & Physical Education Teachers on par with the School Education Department and Municipal Administration & Urban Development Departments in the interest of quality education in Tribal areas with the concurrence of the Finance Department vide U.O.No:2200757/HR.II/ FINO-HROPDPP/CRRD/ 143/2023, Dt: 06.12.2023.

In the reference 4th read above, certain Language Pandits and Physical Education Teachers of TW Department have represented that out of (668) LPs and PETs, only (251) were upgraded, while the remaining (417) posts were not upgraded, whereas in other Departments all Language Pandits (Telugu & Hindi) and Physical Education Teachers were upgraded. Hence, they are requested to do justice for upgrading the remaining 417 Language Pandits (Telugu & Hindi) and Physical Education Teachers as School Assistants. In the reference 5th read above, this office has again submitted proposals requesting the Government for up-gradation of the remaining (417) posts of Language Pandits (Telugu & Hindi) and Physical Education Teachers to the cadre of School Assistants (Telugu,

Hindi & Physical Education).

In response to the above, in the reference 6th read above, with concurrence of Finance Department, the Government have up-graded (417) posts of Language Pandits (Telugu – 227 & Hindi – 91) and Physical Education Teachers – (99) working in TW Ashram Schools to the cadre of School Assistants with the Pay Scale of Rs. 44570-127480 on par with the School Education Department and Municipal Administration & Urban Development in the interest of providing quality education in Tribal areas.

In the reference 7th read above, the certain language pandits have represented to issue orders upgrading them in their present place of working as they are in the middle of the academic year and to ensure no disturbance in the exam preparation of the students.

In this regard, in continuation of the orders issued vide reference 3rd read above, the following guidelines is hereby issued for filling up of the remaining upgraded (417) posts of Language Pandits (Telugu – 227 & Hindi – 91) and Physical Education Teachers – (99) in Tribal Welfare Ashram Schools:

- i. The upgraded posts shall be filled up with eligible teachers from the feeder categories possessing the prescribed qualifications as per the Tribal Welfare Subordinate Service Rules issued vide G.O.Ms.No.45, Social Welfare (TW.SER.III/A1) Department, Dt:28.06.2011 and amendments issued from time to time.
- ii. Language Pandits and Physical Education Teachers who are ineligible / under suspension / under major or minor penalty / absconding from duty, etc., shall continue in the same upgraded posts with their existing scale of pay.
- iii. The promotions now issued are purely on ad-hoc basis in the present place of working and the places now allotted are temporary. so as to streamline academic instruction during the middle of the academic year.
- iv. They shall be allotted permanent places during the ensuing Teacher Transfer Counselling.

Therefore, the concerned DSTW&EOs in the state are hereby instructed to take up promotion accordingly to the upgraded posts as per the instructions issued above. The above process shall be completed within (15) days from the date of receipt of these proceedings.
